RESULTS OF OUR THREE YEAR CARF SURVEY??

Three Year Award through December 31, 2021!!

We have received our formal CARF Accreditation Report. Some of the strengths the surveyor noted:

- RRAF has a strong board of directors that works closely with the executive director. Together they provide a strong foundation for the organization.
- The staff members are skilled at working with people with severe disabilities and stated that, although the work is hard, it is rewarding.
- The organization consistently does long-range planning, and it is fully aware of the challenges it faces and proactively seeks to achieve the organizational goals in spite of personnel challenges.
- The organization is financially stable in spite of a shrinking census and inadequate funding.
- Behaviors are addressed by maintaining a calm environment with activities matched to each peer's capabilities. Although staff members push the peers to grow toward independence, the staff members let the peers learn at their own pace and do not create stress by demanding more than they are capable of achieving.
- The individual plans are created so learning takes place as soon as the peer enters the program, whether or not the funding agency has provided RRAF with direction. When the funding agency provides the umbrella plan, then RRAF adjusts the plan for the person served.
- The individual plans are customized to each peer, taking into consideration the peer's functioning level and the input of his/her parents or guardians.
- The staff members create an environment where the peers are empowered to improve their own behavior and function better with others. The peers are well aware of the antecedents to their behaviors and work to de-escalate behaviors before they become disruptive.

Current Events We Are Keeping An Eye On:

- The Independent Service Coordination agency for DuPage County may be changing as of July 1st from DayOne PACT to Service, Inc.
- With Governor Pritzker's approval and implementation of the 5-year plan ro raise the minimum wage to \$15.00/hour by January 1, 2025, advocates are already at work on our behalf. There is an understanding that reimbursement rates will have to be adjusted to allow organizations like ours to build in the mandatory increases. How the state will work those increases into future budgets is anyone's guess at this time.
- Illinois Rule 119, which covers the requirements for Community Day Service providers like RRAF, is currently being revised. It hasn't been updated since 1999, and a lot has changed since then including the implementation of the Personal Plan and Implementation Strategy process.
- The state has been granted a 3-year extension so that organizations can continue to work towards full compliance in being found fully community integrated, rather than institutional or facility-based.

FROM OUR VP. DAY SERVICES:

Now that the weather is turning for the better, we are increasing our outing frequency and types, along with being able to be outside in our back yard.

This year we hope to do more picnic lunches and BBQ's outside at RRAF, as well as more large group outings like nature walks, taking picnic lunches with us.

This will help us address the need for more community outings, that is a priority focus of the state (and a strong desire for families). Especially, as federal Medicaid folks would like all Community Day Services to be non-facility based as much as possible, to ensure that everyone is clearly integrated into the community.

And, besides, everyone loves to be outside on nice days anyways.

At the beginning of this fiscal year, Marilyn asked me to set targets for program outcomes that I felt most appropriate to work towards this year. These priorities are based on family requests, the group of peers that we currently have, and staffing abilities.

The first outcome was to increase the number of outings. I was hoping for a 5% increase year to year. I'm not sure if we will meet this? But, as staff, we are making a concerted effort to try.

The other two outcomes I chose to put in place are to maximize billable hours – which we are doing, now that routes are stable – and – to maximize our census – a tough area, as it depends primarily on the referrals we get from DayOne PACT and others.

In keeping with the spring theme, I and staff know that we too need to grow and change in order to keep up with the ever-evolving landscape requirements of funders, service coordinators, and most importantly – individual family and peer desires.

Much like the quote by the English poet Algernon Charles Swinburne:

"Blossom by Blossom Spring Begins"

So, too, must we step by step bloom, and spring into something new.
